# Consideration of Approval of September 2019 Meeting Minutes

#### **Consideration of Approval of Expenses**

Bonneville County representation presented to the CCDF Board the details of the Dripp case.

The crime occurred in June 1996. Mr. Tap was tried and convicted in 1998. The county has determined Tap was wrongfully convicted and has now taken Mr. Dripp into custody and charged. Mr. Dripp was charged in 2019. The death penalty was filed in late 2019. Bonneville County believes, in their legal team interpretation, that the JPA states the CCDF Board has the ability to cover the costs in the Bonneville application as it provides for the "operation of CCDF into future years." Bonneville County has requested for the CCDF Board to consider their application.
