### **LEGISLATOR INTRODUCTIONS**

Rep. Shawn Dygert (House, 23B) was introduced and provided background on his prior career and recent election into the state legislature. He recently retired as a high school AG teacher and was elected fir the first time in the most recent election. He mentioned working with Commissioner Dayley on AG career education initiatives. AG is a top priority. Rep. Dygert discussed the importance of seed crop preservation and the benefits of Idaho soil.

Rep. Dygert answered questions from Commissioner Rod Beck about publication requirements. Rep. Dygert discussed some of the challenges with the publication requirements for rural communities and how people consume their information in different ways. Commissioner Zach Brooks discussed possible changes to public notification statute for public entities.

Rep. Dygert discussed the benefits that PERSI retirees can provide a former employer but the need to cleanup who is a bona fide volunteer to ensure compliance with rules to provide peace of mind for a retiree wanting to be of assistance.

Brief discussion occurred about various tax proposals.

Commissioner Sherry Maupin mentioned the impact of tourism in Valley County.
