## Updates from legislators:

Representative Jack Nelsen – Gave updates on: voucher/tax credits for education, keeping speech requirements, water resources agreement, liability concerns for utility companies, liability concerns for companies using Round-Up and concerns for exported vs domestic production.

Representative Lance Clow – Gave updates on: short-term rentals, voucher/tax credit/education savings account plan for education, Lava Ridge Wind Project, 3<sup>rd</sup> bridge crossing for the Snake River Canyon.

Representative David Leavitt – Gave updates on: keeping rules with the legislative body rather than statutes, Lava Ridge Wind Project, retirement pay for veterans, military priority for charter schools.

Representative Mike Pohanka – Gave updates on: visiting Mountain Home Air Force Base and Future Farmers of America, tarping semitruck loads, UTV safety requirements, Air Force base water purification system, 3<sup>rd</sup> bridge crossing for the Snake River Canyon, highway improvement projects for conditions and safety, failed public notice resolution, mask mandates, judge shortages and benefits, fingerprinting bill for those working with vulnerable individuals.

Representative Steve Miller – Gave updates on: JFAC budgets and revenues, the economy, reducing federal budget and its impact on Idaho, concerns for cutting various budgets, tax cuts, labeling law for insect proteins in meats, codifying rules against Lava Ridge and Taurus Wind Projects for future possible projects, Idaho's importance in nuclear power, Idaho's importance to processing spent fuels, Idaho based resources.

Twin Falls County Commissioner Don Hall made a comment calling the Representatives our colleagues and friends, we pride ourselves on our relationships, we are partners, and they are appreciated.

Minidoka County Commissioner Dan Schaeffer made a comment to the Representatives to let them know that we are available to them.

Nomination and Election of District IV Representative to IAC Legislative Committee Alternate:

The position was previously held by Minidoka County Commissioner Jared Orton. He gave a summary on taking an appointment for the Commissioner's and Clerk's Board which meant vacating the alternate position. Commissioner Orton nominated Minidoka County Commissioner Dan Schaeffer. Twin Falls County Commissioner Brent Reinke made a motion to close further nominations. Motion to elect Dan Schaeffer passed unanimously.

## Committee Reports:

ICRMP Report – Twin Falls County Commissioner Don Hall gave updates on: the challenges with the ICRMP and reinsurance market, asking all of us to work with each other to help bring down rates, hiring another law enforcement and jails specialist for training, new policy for post accident drug testing ("may" vs "shall" and having reasonable suspicion) the new policy was requested to be sent to the group.

GEM Plan – Minidoka County Commissioner Jared Orton gave updates on: the group is in good financial shape, no major claims, legislation to allow cities to join with state insurance program.

Legislative Report – Jerome County Commissioner Ben Crouch gave updates on: joint commissioners committee across neighboring counties, the IAC legislative prioties (consolidate elections, public defense reform, tourism tax, public notices, procurement law changes, youth vape prevention, property tax relief, coroner records exemption, hospital tax exemption, health district licensing fees, EMS edified as essential, solid waste disposal responsibility). There was open discussion on public notices, tourism tax, and E911 funding.

IAC Representative Report – Twin Falls County Commissioner Brent Reinke gave updates on: acknowledging and appreciating IAC Board President John David Davidson for conducting the meetings throughout the week, clean financial audit, 4% increase from asset investments, CES out of New Mexico with group buying capabilities and establishing the same process in Idaho to help all 44 counties work as one.
