Minutes of the District IV meeting held May 9, 2024 were presented by District IV Chair Wayne Schenk. Motion was made by Brent Reinke, Twin Falls County Commissioner to approve the minutes as presented. Motion seconded and passed.

District IV Chair Wayne Schenk, Minidoka County Commissioner introduced Senator Kelly Anthon. Senator Anthon told a little about himself and thanked everyone for their service. He asked everyone to be involved because there is a high volume of legislation and it matters that he hears from us. Senator Anthon talked about Idaho growth, agricultural knowledge in legislators, quagga muscles, Senate Bill 1316, artificial intelligence, transparency in election funding and how we let money follow students in education. Discussions were had about quagga muscles, public defender issues, Medicaid and outsourcing of Health and Welfare.

Mr. Wolfe discussed Town Hall Idaho that lists Idaho public meetings, agendas and minutes. Some discussions were had about consequences of not reporting, dollar thresholds on audits and how other states compare to Idaho.

 hurricanes, etc. Idaho does have exposure to catastrophic losses.

- Legislative Wayne Schenk, Minidoka County Commissioner- There have been 18
 resolutions passed and it will be narrowed down to 5 priorities. As Senator Anthon
 mentioned it will be a difficult session with people coming in and change in leadership in
 Senate. We will have elections later today for legislative replacement for Mr. Schenk. Seth
 Grigg, IAC Executive Director, concurred with shifts that Senator Anthon spoke about and
 legislation sounds like mostly statewide issues.
- IAC Representative Report Brent Reinke, Twin Falls County Commissioner- He went over previous meetings where they had an election of a board member, encouraged going to COI meetings, HB208 and SB1403, went over bylaws and minutes, discussed the Dan Chadwick award, Seth went over membership and serving and Seth and Kristin went over finances.
- South Central Behavioral Health Board Angenie McCleary, Blaine County
 Commissioner-Stated that the most exciting thing they do is giving out grants, Drug Take
 Back Days were successful in most counties and they are talking about doing education on
 medical first aid. Melanie has retired and Logan started at the health district.
