VOTER REGISTRATION INSTRUCTIONS

When returning your Combined Voter Registration Absentee Ballot Application, make sure you include the following as set forth in Idaho Code §34-408A regarding Election Day Voter Registration:

- ☐ Completed Combined Voter Registration Absentee Ballot Application (Form VR-ABS-1)

AND a photocopy of one of the following groups of items for identification purposes:

- ☐ Idaho Driver's License with current address

— **OR** —

- ☐ A valid photo identification card **AND**

- ☐ A document which contains your name and a valid address in the precinct. This document must be dated no later than April 19, 2020 to fulfill the requirement of residency at least 30 days prior to the election date.

— **OR** —

- ☐ A current valid student photo identification card from a postsecondary educational institution in Idaho **AND**

- ☐ A current student fee statement that contains the student's name and valid address in the precinct. This document must be dated no later than to April 19, 2020 to fulfill the requirement of residency at least 30 days prior to the election date.

AND

- ☐ This completed checklist
