Minutes Approval (Action Item)

Nez Perce County Commissioner Doug Zenner moved to approve the September 2019 meeting minutes. Idaho County Assessor James Zehner seconded the motion. The motion carried.

Legislative Priorities Set

The IAC Legislative Committee convened to prioritize policy member initiated legislative resolutions adopted by the membership at the September Annual Conference. The committee considered 18 resolutions and after discussing each resolution established the following eight legislative priorities:

1. IG-12 Idaho Protection of Public Employees Act Limitations

IAC promotes county interests, encourages ethical behavior, advocates good public policy on behalf of Idaho counties, supports best practices, and provides education and training to assist Idaho county officials in performance of public service.

2. IG-06 Administrative Procedures Act
3. JPS-03 Collection of miscellaneous fees through Odyssey
4. JPS-04 Pretrial release
5. IG-08 Write-in deadline
6. IG-14 Title fees
7. IG-04 Homeowners exemption
8. PL-01 Fees for roads on IDL lands

The Committee elected to designate the remaining resolutions as IAC legislative policies and directed staff to work on them in addition to IAC's legislative priorities where possible. These policies include:

- IG-01 Local Option Tax
- IG-02 Ballot Recount
- IG-09 Brokered CDs
- IG-10 Uncontested City Elections
- IG-13 Marriage Licenses
- IG-15 Property Tax Relief

PL-02 and PL-03 are policies rather than legislative items and will be worked on as non-legislative priorities.

JPS-06 will be introduced by Latah County Clerk Henrienne Westberg.

JPS-07 was tabled in order to pursue alternative options.

Other Business

Nez Perce County Commissioner Doug Zenner moved to support legislation to consolidate the current expense, justice and charity levies into a single general fund levy, Payette County Treasurer Donna Peterson seconded the motion. The motion carried.

James Zehner moved to adjourn the committee meeting at 1:00 pm. Twin Falls County Assessor Brad Wills seconded the motion. The motion carried.
