#### Call to Order | *Vice Chair Steve Smith*

#### Consideration of Approval of September 2019 Meeting Minutes

*Doug Zenner moved to approve the September 2019 minutes. Sabrina Young seconded. Motion carried.*

#### Idaho State Tax Commission Rule Changes | *Alan Dornfest, State Tax Commission*

Alan Dornfest shared that so far there have been no objections to rules that the committee worked on last summer and fall. Brian Stender shared that one senator had two questions on urban renewal but those were the only questions on either packet in the House or Senate.

Dornfest shared there has been an executive order creating a moratorium on rule making this year. Only exceptions would be if a law change makes a rule invalid.

#### Legislative Priorities Update

Sara Westbrook updated committee on Whistleblower Act legislation. She addressed a question regarding whether we anticipate any other opposition in addition to the Trial Lawyers. She said they did not anticipate any.

Westbrook gave an update regarding the title fee re-allocation legislation. The outlook does not look positive. Brian Stender shared that while it might be possible to increase admin fees on registration to fund title-fees, it would not be right because they are not always directly related.

Westbrook shared the Marriage License Clarification legislation has been flagged by the ACLU. Governor's office, ACLU and IAC had a conversation about the legislation.

Henrienne Westberg gave an update on the write-in deadline legislation. Some legislators wanted 60 days others wanted 8 weeks. Kelli Brassfield and Henrienne met with Rep. Carolyn Nelson-Troy. She agreed to carry it on the House side. Jared Larsen from Governor's office was also involved. It will start in the Senate with Mary Souza as sponsor.

Westberg shared that the Security of Ballots legislation is Senate bill 1269. No problems foreseen. A hearing is scheduled for later this week.

Westberg shared that the Uncontested City Elections bill came out of the Senate. S1270 says if there is no contest on the city election, then counties do not have to run an election. Has not been significant push back.

Sara Westbrook shared that the Administrative Procedures Act legislation currently proposed will not affect counties, so legislation is not needed.
