Minutes Approval (Action Item)

Nez Perce County Commissioner Doug Zenner moved to approve the August 18 meeting minutes. Twin Falls County Commissioner Don Hall seconded the motion. The motion carried.

Discussion Items

- Legislative prioritization
 - IG-01 as amended, focuses on funding the Affordable Housing Trust Fund with an inclusion to amend the income allowance levels.

Nez Perce County Commissioner Doug Zenner moved to table IG-01. Twin Falls County Commissioner Don Hall seconded the motion. The motion carried.

Twin Falls County Commissioner Don Hall moved to take IG-01 off the table. Bonneville County Commissioner Terrel Tovey seconded the motion. The motion carried.

Bonneville County Commissioner Terrel Tovey moved to send IG-01 as amended to the full body for approval. Payette County Treasurer Donna Peterson seconded the motion. The motion carried.

- IG-02 removes the 5-day requirement and allow counties to remit court fee funds on by the 15th of the month and to strike the word treasurer from the related code section.

Bonneville County Commissioner Terrel Tovey moved to send IG-02 to the full body for approval. Onybee County Clerk Angie Barkell seconded the motion. The motion carried.

- IG-03 increases investment options for county treasurers.

- IG-04 allows for vaping products to be taxed at the same rate as tobacco products with a portion of the tax set aside for public schools and a portion set aside to help fund juvenile probation services.

- IG-05 provides for an alternate revenue stream for counties through establishing a property tax relief fund.

Bonneville County Commissioner Terrel Tovey moved to send IG-05 to the full body for approval. Twin Falls County Commissioner Don Hall seconded the motion. The motion carried.

- JPS-02 would move public defense to a state-based system.

Nez Perce County Commissioner Doug Zenner moved to send JPS-02 to the full body for approval. Bonneville County Commissioner Terrel Tovey seconded the motion. The motion carried.

- JPS-03 would change coroner requirement to report cases to treasurer's office from 48 hours to 72 hours.

Onybee County Treasurer Annette Dygert moved to send JPS-03 to the full body for approval. Nez Perce County Commissioner Doug Zenner seconded the motion. The motion carried.

- JPS-04 changes when a coroner is authorized to proceed with an indigent cremation from 14 days to 10 days.

Valley County Coroner Scott Carver moved to send JPS-04 to the full body for approval. Nez Perce County Commissioner Doug Zenner seconded the motion. The motion carried.

Payette County Treasurer Donna Peterson moved to adjourn the meeting at 2:32 pm. Nez Perce County Commissioner Doug Zenner seconded the motion. The motion carried.
