#### Review/Approval of February 3rd 2022 Meeting Minutes –Brian Walker

#### Approval of meeting expenses- Brian Walker

• Around \$450 for lunch. Tim Howley moved to pay for half the expenses (split with Misdemeanor), Nadine McDonald seconded.

#### **Non-Action Items:**

- Rule of 80 Brian Walker
  - Acknowledgement of those who came before to help make this happen. Thanks to all those who worked to get it passed this year.
  - 7/1 it goes into effect, employees should contact PERSI representatives to see how it impacts them directly.
- ARCON Seth Scott, Karen Skow, and Shawn Anderson
  - While interest is there, it will take about a year to get everything in place. Will use AUF until then. Counties can start training in ARCON with local instructors; however, recognize they are trained in a different kind of ARCON, so they will train on things Juvenile won't use.
  - Shawn has started to set up what the JJ track of ARCON will look like and will take the template to the training council for approval for JPO training academy. Similar to Misdemeanor ARCON, not as many techniques.
  - Discussion about Detention moving to ARCON.

- **MOTION:** Nadine McDonald motion to move forward with adopting ARCON for Juvenile Probation, Elda Catalano seconded.
- **MOTION:** Seth Scott motioned to move forward with adopting ARCON for Juvenile Detention, Skip Clapp seconded.
- There is a workgroup from probation, need one for detention.
- It will continue to be up to each department how they continue training after POST, similar to current AUF practice.

# • HB 500 - Representative Marco Erickson and Erica Marshall

- Gave some background and history of the proposed bill. The overall aim is how to help families more without losing services and resources.
- Looking for information on how fees impact the running of programs so there can be replacement funds from the State.
- Shared the report on fees put together for HB 500.
- Suggestion to ensure BOCC, Judges, and IPAA also have the ability to weigh in.
- Restitution purposefully left out.
- Looking for information on what fees are assessed by category and how much in each category.
  - Next, where were the collected fees applied to support programs.
- Data pulled from ICOURT shows about 54% of fees are being collected.
  - Concerns about accuracy of data since switching from ISTARS.
  - Consider one bill to address making counties whole with fee removal rather than separating them to gain IAC support.
  - Concern about unfunded mandates and ensuring consistent methods of data collections across counties.
- Discussion about detention centers and how one county hosts the detention center and bears costs, and other counties pay for use, so some fees get more complicated as county budgets are impacted by using facilities out of county. Also impacts to Juvenile Training Budget.
- Potential workgroup for this topic.

# • Juvenile Updates - Jason Dye

- Reviewed amended and proposed rule changes see attachment sent previously.
  - Rules 27 and 54 updates go into effect 7/1.
  - Specific updates on modifying a 20-511A order.
- Proposed changes to IJR 26, add rule XX to come in line with the H.B. 452 for placement of youth charged as adults.
- Discussion around how youth are charged on future charges when a youth is waived. There is a process for future charges to come back to juvenile court.
  - Any training for IDOC on processes for waived youth on blended sentences? There is education available, need more.
  - Possible supervision options for blended sentences still fall under JCA so can be supervised by JPOs.
- Review and Discussion of the proposed revision to the Juvenile Probation Standards - Matt Olsen
  - Regular reviews per Governor's Red Tape Reduction Rule. Shared current review team.

- Proposed modifications sent out: grammatical updates, some standards broadened, ensuring consistency with existing rules, and a few deletions for duplications.
- Send feedback to Matt and Chelsea.
- IDJC Updates and Introduction for the New JCC Nampa Superintendent and the new JCC St. Anthony Superintendent Director Prow
  - Introduced David Birch, Superintendent at JCCN.
  - New Superintendent at JCCS Alvin Winegar.
  - See handout on EPIC updates (formerly Length of Stay).
  - $\circ$  Smart Vault 1/3 of counties using it, moving to this system for commitment packets. Better than email for security and can submit large files at once.
  - IDJC has to cut 20% from rule sets, so plan to drop provider rule set.
  - One time funds coming from Idaho Behavioral Health Council initiatives, more below on funds coming through IDJC.
- 11:00 a.m. Introductions of the new Program Manager for the Assessment and Crisis Center and Discussion Jason Stone
  - Introduced Holly Walund.
  - See handout on Assessment and Crisis Centers. Grant Solicitation for Assessment Centers live today on IDJC website.
  - Flexibility to work within the National Assessment Center framework, and it can look different for each applicant.
  - NAC coming to do 2 regional trainings (Boise 3/25, Idaho Falls 3/26) ability to participate in person or virtually. Opportunity for technical assistance on grants afterward for applicants.
    - Hardwired into the grant is membership with NAC to access their templates and assessments and other resources.
  - Discussion about sustainability and community meetings to get community support and buy in.

## • Other Business

- Psychosexual Evaluations for juveniles discussion about asking for CBAS funds to cover these. Currently counties handle this differently. Add to agenda for June meeting. Would be helpful to know the scope of numbers and potential costs.
- ICOURT update and now there are restrictions on access to critical information. The roll out from Odyssey automated some restrictions.
- Request for additional detention academy high turnover in staff has increased the need. Discussion about regional POST.
- ICADD will have the Probation Simulation as a session, come help if able.
