HB735 Indigent/CAT Program

- CAT program will remain in place through July 1, 2023 to process applications
- Applications will be processed according to Chapter 35, Title 31 as it existed on March 1, 2022
- Counties must process all applications for financial assistance, including suspended applications, by March 1, 2023 in order to allow CAT to act upon applications for services received prior to March 31, 2022
- Non-medical may continue



What Now?

- Still collect reimbursements
 - Reimbursements will be deposited into the county current expense fund. NOTE: Where possible, be sure to segregate reimbursements to be remitted to the state
 - Remit CAT portion as you have
- Applications
 - Dates of service prior to March 1, 2022
 - Dates of service from to March 1, 2022 to March 31, 2022
 - Dates of service after March 31, 2022
 - Suspensions/appeals



Public Defense



Governor's Working Group

- Governor's Office is joining IAC in the creation of a working group to explore alternative public defense models.
- Four county commissioners will participate in the working group for geographic and demographic representation,
- Public defenders and legislators will also participate.
- Kickoff meeting will take place later this summer.
- Likely alternatives will include a regional/judicial district based model with some level of state oversight.
- System will be fully funded from non property tax revenue sources.

- Sales tax replacement for property taxes.
- Increased reliance on user fees, like fuel tax, registration fees, impact fees, and other user generated revenue sources.
- Repeal of sales tax on groceries.
