C. Capital Crimes Committee

Commissioner Mark Rekow reported that three counties are participating, and they are allocating for a fourth. There is 5.2 million dollars in the account.

E. Catastrophic Health Care Fund (CAT) Committee

Kelli Brassfield (IAC) reported that there was a meeting in April and there were seventy nine total cases. It is being held hostage by the House (HB 316). The fund is currently in the hole. There is another meeting scheduled for June, may not happen until there are answers from the Legislature.

F. IAC Committee

Assessor Mark Harvey reported that they are working on scholarships. There were fifty three applicants. The award letters will go out the first of May.

The Board of Directors received the audit report. All expenses were accounted for and everything was in good order.

The Policy Manual is being reviews, put in effect in 2021.

Shoshone County's funding for Defense Litigation Supplement was approved.

Seth gave update on IAC strategic plan.

X. GUEST SPEAKERS:

A. IAC Legislative Update, Kelli Brassfield reported on

House Bill 316: Counties would pay for Public Health Districts instead of the State. There has been concern and pushback. Hospitals are concerned about having to absorb the costs of involuntary holds which are addressed in subsection 3.

Senate Bill 1060: Gives Commissioners the ability to approve or deny emergency orders, it has been approved. The language of HB 316 must match the language of this bill. Meeting with the Department of Health and Welfare about precommitment costs. Would be a trailer bill to HB 316.

Senate Bill 1061: Is a cleanup bill about elections timelines. The bill was amended in the House to include information on the removal of August elections. The bill will be voted on in the House tomorrow, it will probably die in the Senate.

Senate Bill 1111: Creating city districts for cities with a population over one hundred thousand. It is a clean up bill to fit with census data. The House amended the bill to move all city elections to November of even number years. The Senate will probably kill this bill.

The one time funding on transportation should be received in April or July.

House Bill 362: The first eighty million will go to the state, locals will get the rest. The bill will increase funding from sales tax to 4.5%. The states portion will stay flat at eighty million but the locals will increase over time. This bill is on the third reading calendar for the Senate. There has been discussion on possible amendments.

Property Tax: The proposed changes include a cap on local government at 5% (3% plus new construction) or CPI plus new construction. Foregone funds would be involved. Budgets would be capped at 3%. Homeowners exemption being increased to 125,000. There have been proposed changes to the circuit breaker program as well. 150% of median value, this would help keep people on the program. 31,900 income level, 1500 max amount.

Moyle Bill: Working on new construction, no details as of now. Business personal property, tied to state budget.

Emergency Management (House Bill 135 and Senate Bill 1136). HB 135 is on its second reading. SB 1136 is on the Governor's Desk. Emergency Managers would like Legislators to hold off. They would like both bills to be vetoed.

The Senate has recessed until Monday. The Legislature may go into the first week of May.

XI. OLD BUSINESS

A. H. Sydney Award for Excellence in County Government.

Chairwoman Elizabeth Mahn discussed the nomination of Alan Dornfest from the State Tax Commission. He was our Districts choice. This is not public information at this time.
