I. CALL TO ORDER

Chair Stacy Dreyer called the meeting to order at 9:01 A.M.

II. PLEDGE OF ALLEGANCE

III. INVOCATION

IV. ROLL CALL

VI. APPROVAL OF THE MINUTES OF THE REGULAR MEETING ON JULY 19, 2019

A. ACTION: Commissioner Tom Dale moved to approve the corrected minutes. Treasurer Annette Dygert seconded. Motion carried.

VII. BANK REPORT

Treasurer Elizabeth Mahn reported there have been no transactions and the account balance as of the September 25, 2019 statement period remains \$650.76. Discussion on assessing each district an equal amount to increase the bank balance to \$1,000.00.

A. ACTION: Treasurer Donna Peterson moved to approve the bank report and assess each district to increase the bank balance to \$1,000.00. Treasurer Sabrina Young approved. Motion carried.

VIII. BYLAWS

- **B. ACTION:** Commissioner Rick Visser moved to amend Article II, Section 1, as proposed. Treasurer Sabrina Young seconded. Motion carried.
- **C. ACTION:** Commissioner Tom Dale moved to add new Article III, Section 1, subsection F as proposed. Assessor Mark Harvey seconded. Motion carried.

IX. BOARD AND COMMITTEE REPORTS

A. Idaho County Risk Management Program (ICRMP) Committee

Commissioner Marc Shigeta reported on the ICRMP Risk Management Discount Program and the 5% discount for successful completion of the program.

B. Legislative Committee

Commissioner Tom Dale reported the next legislative session will likely address Medicaid expansion, public defense and property taxes. Discussion on the Property Tax Working Group, which meets again on November 18, and how counties can get involved.

C. Capital Crimes Committee

No update.

D. Gem Plan Committee

Commissioner Marc Shigeta reported that the Gem Plan added Blaine County and Idaho County as new members. Discussion on the increasing costs of dependent coverage.

E. Catastrophic Health Care Fund (CAT) Committee

Commissioner Rick Visser reported that Medicaid expansion enrollment begins November 1, 2019 and there will be more information in January on the impact on counties.

F. IAC Committee

Kristin Cundiff of IAC reported that IAC's strategic plan includes expanding training and offering additional programs and services to counties. IAC is preparing for its midwinter legislative conference in Boise in February 2020.

X. NOMINATIONS FOR SECRETARY/TREASURER

Discussion on nomination of a Coroner for Secretary/Treasurer.

A. ACTION: Clerk Douglas Miller moved to nominate Coroner Aaron Tines. Commissioner Tom Dale seconded. Motion carried.

XI. SWEARING IN OF OFFICERS

Chairman Stacy Dreyer swore in Clerk Douglas Miller as Chairman-elect and Treasurer Elizabeth Mahn as Vice Chairman-elect.

XII. GUEST SPEAKERS: Terry Scanlan, Vice President, SPF Water Engineering and Scott Campbell, Attorney, Campbell Law Chtd.

Presentation on Elmore County's Aquifer Recharge Project. Review of study finding a groundwater deficit in Elmore County, which inhibits economic growth. As a result of the findings, three water right permits were submitted — the Canyon Creek recharge permit; the South Fork Boise River at Anderson Ranch Reservoir permit; and the Snake River water permit. Presentation of the status of the permits, contested water rights hearings involving Boise City and Idaho Power, and a permit granted in favor of Elmore County allowing for trans-basin diversion.

XIII. BREAKOUT SESSION REPORTS

A. Assessors

Assessors discussed the Property Tax Working Group and the challenges finding a solution that meets different needs of all counties and cities; how different jurisdictions pay for VIN inspections; and that Ada County is limiting tax cancellations to 3 years.

B. Treasurers

Treasurers discussed that 2019 levies had been approved, the upcoming tax drives, and the Property Tax Working Group.

C. Clerks

Clerks discussed upcoming elections and new software at the Secretary of State.

D. Commissioners

Commissioners discussed land use issues (BLM and Forest Service) and budgetary challenges when balancing overtime, comp time, merit and employee retention.

E. Prosecutors

No report.

F. ACTION: Commissioner Kirk Chandler moved to approve the reports as presented. Commissioner Tom Dale seconded. Motion carried.

XIV. NEW BUSINESS

Discussion on offering a District 3 scholarship to local high school students. Will keep in mind for further discussion at a later time.
