I. Call to Order & Roll Call

Rinehart called the meeting to order at 8:00 am on Friday, February 3, 2023. The members went around the room to introduce themselves for roll call. 23 members were present and 21 members were absent.

II. How to Get Involved in ISACC and IAC

President Rinehart explained to the members how they can be involved in ISACC and IAC. This includes attending the ISACC and IAC Conferences. For ISACC, you can run for a position on the ISACC Board or volunteer to be part of the ISACC Education Committee. IAC has policy committees that you can sign up for each December. The committees meet twice at the IAC Annual and IAC Midwinter conferences.

III. Review of ISACC Board and Education Committee Meetings

President Rinehart briefly reviewed the ISACC Board and Education Committee meetings. The Board approved sending an unlimited number of coroners and deputy coroners to the IACME Symposium in Las Vegas. More information will be sent out in the next month so watch your email inboxes. IV. Legislative Update

Carter provided the legislative update for the members. About half of the legislature is new and therefore, not many bills have been introduced. There are quite a few new committee chairs and so it has been a slow start to the session. IAC prioritized five bills in the legislative committee last fall but have since reprioritized based on feedback from the legislators and committee chairs on what might not be feasible. Carter will continue to attend the IAC Legislative Committee meetings as the representative for the association and provide information to the members when needed.

V. ISACC Financial Report

President Rinehart reviewed the current financial report for the association.

Ernest moved to accept the financial report, Piper seconded. Motion passed unanimously.

VI. ISACC Bylaws Review and Voting

President Rinehart reviewed the proposed amendments for the association. The members had a few questions but ultimately there were no issues with the proposed amendments.

Rose moved to accept the ISACC constitution and bylaw amendments as presented, Danner seconded. Motion passed unanimously.
