Advanced JPO Certification Discussion and letter to POST Council – Jordynne Ketchum

- Juvenile Detention doesn’t have an advanced certification either, may want to include it.

- Need to come up with standards for the advanced certificate. May not need to be as robust as Misdemeanor. Carol will share documents from POST for a better understanding.
- Will need full POST Council approval, then it will go to the legislature with other POST updates in 2025.
- Usually it's years of service, training hours, and advanced education that contributes to the certification rather than specific POST courses.
- Revisit in December to determine criteria.

Non-Action Items:

- **Rule of 80 (amend current Bill)**
 - There have been meetings, one set for 9/23 at the Meridian City Building, only certain groups are invited. PERSI is hosting it. There is only one spot for a Juvenile Justice Representative, Brian Walker will represent IACJJA. Shawn Hill will represent Adult Misdemeanor.
 - PERSI is worried about having to go back and redefine who is eligible. Other options are to run legislation to add supervisors or the Governor can do an executive order, though that may just be a band aid.
 - Goal is to have everyone intended added – the initial intent was for supervisors to be included by IACJJA, which was reflected in the numbers presented to the legislature by each county.
 - Worst case scenario would be taking new legislation – the same people who ran legislation last time said they will carry it again if needed.
 - The issue came down to “supervisor” in the title, legislation didn't include that language, though the intent was to include everyone POST certified.
 - Thanks to Brian for leading the effort and being strategic in addressing this issue.
- **ARCON**
 - December training is full. \$600/trainer – IDJC is covering the fees.
 - POST approved two extra days for ARCON training in Academies, they will start on a Thursday now to accommodate ARCON.
 - POST hosts other trainings around the state. Work with Regional Coordinators on those, as well as instructor development courses.
- **IDJC Updates-**
 - See update sent out by Jason Stone with updates on Youth Assessment Centers, Youth Crisis Center, and EPIC rolling forward.
 - Holly Wallund gave an update – Youth Assessment Centers have spent 18% of funds. The centers are at varying stages. A few will be able to start accepting referrals in October.
 - Most are currently working on establishing boards, developing policies and procedures, and training staff.
 - Hoping Youth Crisis Center grant announcement will go out at the end of the month and it should close around 11/4.
 - Stace shared some updates on YLSI – when youth come from IDJC custody, updated assessments need to be changed to community. Also,

after JPOs leave a county, please email Stace or Alicia to remove their access to GEARS.

- **Other Business**
 - Non-PREA disclosures – working on ensuring the forensic interviews are working.
 - Discussion about having something similar to a bench card for staff to refer to about how to handle disclosures in the office, detention, or an IDJC facility.
