OLD BUSINESS:

6TH DISTRICT DUES AMOUNT- Discussions were held on if the amount due to each county should be increased. Clark County Commissioner, Greg Shenton, motioned to increase county dues from \$150.00 to \$250.00, Fremont County Clerk, Abbie Mace, seconded, motion carried. The increase will go in affect fiscal year 2022-2023.
