Action Items:

- Idaho Juvenile Justice Association Update: The IJJA program is close to being finalized and some of the many topics include, compassion fatigue, mental health, status offenders, assessment centers, sex offender supervision, eating disorders and much more! IJJA membership dues are due at the end of this month in order to be considered for a scholarship. The conference is 9/12 and 9/13/22. The probation simulation training will take place on 9/12 from 3:15-5pm and they will need a total of 18 volunteers. Please let Shawn Hill know if you or one of your staff can help out.
