Call to Order & Roll Call - Torey Danner, Bannock County, President

President Danner called the meeting to order at 2:30 pm MT. Kelli D. Brassfield called the roll.

Minutes - 01-30-2025 (Action) - Torey Danner, Bannock County, President

Lemhi County Coroner Mike Ernest made a motion to approve the minutes from January 30, 2025, Benewah County Coroner Carrie Nordin seconded. Motion carried.

Old Business - Torey Danner, Bannock County, President

Concerns regarding last year's elections were raised, with discussion around differing interpretations of how the process was handled. President Danner emphasized that the current Board has implemented positive changes and successfully overseen an election since then. Dialogue continued around processes and expectations, and members were invited to share suggestions for improvement. Key recommendations included enhancing communication, transparency, and accountability.

Seth Grigg noted that many associations have existed for decades—some for over 100 years—and have had time to refine their processes. He encouraged members to share ideas with the Board that could help strengthen and unify the association.

Some of the suggested ideas included:

- Adding opening ceremonies (such as a color guard, Pledge of Allegiance, and welcome)
- Improving board communication (regular memos to members on association activities)
- Implementing a more formal election process
- Publishing committee information on the website (e.g., Education, Bylaws, Legislative)
- Appointing a parliamentarian to ensure bylaws and Robert's Rules of Order are followed
