- Clay informed the group of the new submission process.
- Jared Orton discussed possible resolutions for jail cost housing.
- Kim asked about the travel and tourism tax increased - where is IAC at with pursuing this.
- Clay answer question about
- Orton asked to talk Anthon to get on board for next session for tourism tax.
- Orton asked about a resolution about a possible rainy day fund option for counties regarding budget reform.
- Commissioner Brooks wants to run 2 resolutions he ran last year with public noticing, Concerning the health districts and food inspections with reducing the subsidizing the inspection fees. Additional possible resolution about health district reform regarding contribution to the districts just for the discussion.
- Brooks then also mentioned Canyon's PA and Skaug threw a bill out there about adjusting the payment from the counties to the state for inmates to spark conversations about that unfunded

mandate. Asked for committee members to look at the Ada county unfunded mandate list to look for potential low hanging fruit that can be easily addressed.

- Discussion from Josh after regarding how fees can be adjusted by having the legislators allowing the commissioners to set fees at cost rather than fixed amounts.
- Discussion of Cannon's truth in transparency issue Clay provided an update that there has been no further discussion other than Cannon's statement of intent to bring some version back with more practical noticing timelines.
